GCE ORDINARY LEVEL (GCE O Level)

GCE O Level grades A*(a*), A(a), B(b), C(c), D(d) or E(e) indicate the standard reached, grade A*(a*) being the highest and grade E(e) the lowest. Performances below the standard of grade E(e) are not reported on certificates.

Certain language syllabuses contain oral tests. Where the candidate has passed the oral test this is reported on the certificate.

The text Advanced Subsidiary, Advanced Level or Ordinary Level prefixing the grade awarded indicates the level that the grade was awarded for the syllabus.

Explanatory Notes

This is a General Certificate of Education (GCE) statement of results for Advanced Subsidiary Level (AS Level) and Advanced Level (A Level). Cambridge International Examinations reserves the right to amend the information on this statement. Results will be confirmed by the issue of certificates.

GCE AS Level results are reported on a 5-point scale of grades: a(a), b(b), c(c), d(d) or e(e), grade a(a) being the highest and grade e(e) the lowest. The content and difficulty of a GCE AS Level examination is equivalent to the first half of a corresponding GCE A Level.

GCE A Level results are reported on a 6-point scale of grades: A*(a*), A(a), B(b), C(c), D(d) or E(e), grade A*(a*) being the highest and grade E(e) the lowest. Under some circumstances where a candidate has entered for a GCE A Level but does not achieve a grade E(e) or above, a GCE AS Level grade a(a) to e(e) may be awarded in the syllabus.

The text Advanced Subsidiary or Advanced Level prefixing the result indicates the level at which the result was awarded for the syllabus.

UNGRADED indicates a standard below that required for grade e(e) for GCE AS Level and grade E(e) for GCE A Level.

NO RESULT indicates that a result cannot be issued because of absence for the whole or part of the examination in the syllabus or because of a decision not to issue a result for some other reason.

PENDING indicates that a result cannot be issued at present but will follow in due course.

The assessment of a language syllabus Speaking component is shown as 'With Distinction in Speaking', 'With Merit in Speaking' or 'With Pass in Speaking'. Candidates who are Ungraded in the Speaking component will have no record of their speaking performance printed on their statement of results or certificate.

Only syllabuses in which GCE AS Level grades a(a) to e(e) and GCE A Level grades A*(a*) to E(e) are achieved will be reported on certificates.
